A Renewed Affiliation Agreement

The Valley Community Foundation (VCF) signed a new Affiliation Agreement with The Community Foundation for Greater New Haven (TCF) during 2018. The signing, which officially occurred on May 18th, marked the fourth such formal Agreement between the two permanent community endowments. Unlike previous

Agreements however, the latest will govern the relationship throughout the next 10 years with annual renewal opportunities.

"This latest Affiliation Agreement underscores the strength and bond of the relationship between our two organizations, and has been instrumental in making it possible for VCF to connect, build, and expand the possibilities for community philanthropy in the Valley," said Sharon Closius, VCF President & CEO.

"The creation of VCF 15 years ago was a very deliberate step by TCF and Valley community leaders to tap the powerful spirit in the Lower Naugatuck Valley in a new way that could build a permanent philanthropic resource," said William W. Ginsberg, TCF President & CEO.

As with previous Agreements, TCF will continue to provide back-office support to VCF and annually distribute the equivalent of 90 percent of the distributable amount of its Gates Fund to VCF. Historically this has amounted to more than \$1.1 million each year. VCF, in turn, reinvests these dollars into resources, initiatives, and a diversified grant program to benefit the Valley. The Gates Fund was established by Derby brothers, Frank and Ross Gates, more than half a century ago at TCF for the benefit of the Valley.

"From our perspective, VCF is a Valley success story that validates both our original reasons for creating VCF and our generous support for it since 2004," Mr. Ginsberg added. "We look forward to a continued partnership of close strategic and operational alignment that can build a stronger community for all."

The Great Give®

The Great Give® is an annual 36-hour online giving event created in 2010 by The Community Foundation for Greater New Haven (TCF) to increase philanthropy in its 20-town region, which has tremendous participation in the Valley.

More than \$1.75 million was raised in The Great Give® 2018, which included donations from individuals, prize money from corporations, as well as matching prize money from TCF and the Valley Community Foundation (VCF). For the sixth consecutive year, VCF has been the second largest sponsor of the event, incentivizing giving by matching funds and offering prizes to participating organizations.

Once again donors showed their generosity toward the Valley and beyond. Gifts made by Valley residents, Valley-based employees, and VCF donor advised fund holders totaled approximately

\$211,000. During The Great Give® 2018, 50 Valley organizations located in Ansonia, Derby, Oxford, Seymour, or Shelton received just under \$180,000 via 2,146 gifts. Overall during The Great Give® more than 15,000 gifts were made to support over 400 participating nonprofits that serve the Greater New Haven region. Connecting:

The Valley Community Foundation (VCF) and The Community Foundation for Greater New Haven (TCF) partnered to organize a social event for area young professionals at Bad Sons Beer Company in Derby. Members of the Valley's Young Emerging Professionals group joined the Connecticut Young Professionals of Greater New Haven for a fun and engaging evening of networking with drinks, food, and information.

Nearly 100 attendees learned about The Great Give® 2018 as well as what volunteer opportunities exist with Valley nonprofits. Executive directors, board members, and volunteers from 25 organizations presented a series of live one-minute infomercials about their nonprofit and why they should be supported during The Great Give®. Bad Sons also supported The Great Give® through its Charity Tap Line during the month of April by contributing \$1 from every pint poured towards a prize in the 36-hour online giving event, which totaled nearly \$1,500.



Building:

In 2011, VCF Board Member, Frank Michaud, and his wife, Judy, established the Health Initiative for Men (HiM) Fund to support men's health activities and programs at Griffin Hospital. Every June, Frank personally delivers thousands of Father's Day cards to schools in Ansonia, Derby, Oxford, Seymour, and Shelton, so students can bring them home to their fathers or guardians. The cards come with an important message to fathers in the Valley – take care of yourself. The cards also include a checklist for these men to bring with them the next time they visit the doctor.

Frank has made sizeable annual contributions since the fund was created at VCF. His commitment to building an existing fund continues to deepen its community impact and illustrates that this process is just as meaningful as establishing a new fund.


Expanding Possibilities:

VCF was contacted to assist the Derby High School track athletes attend a national championship meet that would be held out-of-state. While the Derby Running Club was conducting their own fundraising to make this happen, VCF staff reached out to two anonymous fund holders with a special appreciation for the City of Derby, who helped the team reach its fundraising goal.

After the donors contributed the balance needed, members of the Derby track team were able to make the trip and compete on a national stage. Both their families owned neighborhood grocery stores: Charles Hron and Peter Alesevich were the proprietors of Hron's Market in Stratford and Shelton Arms Market in Bridgeport, respectively. Through their parents' examples, Chris and Sam have carried on a tradition of providing for and welcoming family and friends. They are known for gatherings to celebrate holidays, special occasions, and those spontaneous get-togethers that make life grand. The table is always full of Chris' culinary creations with attention to individual tastes. Sam, who is known to enjoy Chris' cooking, reaches out to help family and friends with his ability to fix just about anything.

When Chris and Sam decided to formalize their years of giving to the community and explore the best way to establish their legacy, they sought information from Liz Kennard, their dear friend and founder of the Mary Fund at VCF. This led them to the Valley Community Foundation.

Spending their working lives as educators, Chris in primary grades teaching children to read and write and Sam teaching printing and graphic design to high school students, they know the impact of caring teachers and public education. "We have a special place in our hearts for both the young and old," Chris shared. "As educators, we not only want to support youth programs, but we also want to respect the elders of our community and the contributions they make."

“We thought it would be great to give them something that would last forever and have a real impact on the Valley,” Kurt explained. The fund was established in 2017, and was steadily built up every month until it became endowed at the Valley Community Foundation (VCF). What started out as a Mother’s and Father’s Day gift, now has the ability to give back to the community Carl and Patricia Miller love so dearly.

“Our parents led by example and perpetuated their strong values of giving back, which we still carry with us,” Kurt said. “My brother and I were blessed to have had such a wonderful childhood. We want to share our resources with kids who wouldn’t otherwise have the same opportunities we did growing up. That’s why we will be making grant recommendations from this donor advised fund to help Valley kids participate in summer camps and a range of youth programs.”

“When we decided to move forward with creating a fund, we didn’t look anywhere but VCF for help,” John added. “VCF President and CEO Sharon Closius made it extremely easy to get our fund up and running. She answered our questions and accommodated our busy schedules. I especially appreciated the ability to be a part of this process long distance from Boston.”

Kurt and John’s parents were a little taken aback by the idea of them creating a fund in their name, but in a good way according to the brothers. “They became very excited once they understood why we did it, how it works, and what we would like to accomplish,” Kurt said. “We then discussed other ways to grow the fund, especially as it relates to estate planning.”

“Everyone should consider creating a legacy,” he added. “People often think it’s an intimidating process or that you need a substantial amount of money, but that’s not true. VCF made it simple for us to make small, consistent contributions to build our fund so that we can have a lasting impact on the community.”

John said, “We are grateful that our parents are able to work with us to make grant recommendations and begin to see the effects of this fund, knowing that it will continue to make the Valley a better place for generations to come.”

Derby-Shelton Civil War Monument Preservation Fund



The start of a new project is arguably more exciting than its maintenance, but without that care, the Community might well lose a treasure. The Derby-Shelton Civil War Monument Preservation Fund will ensure the future of a landmark that longtime Derby resident, Jamie Cohen, fondly remembers as part of his youth. As

with many things in the Valley, this Fund's creation comes with a rich history.

"I was a member of the Derby Cub and Boy Scouts growing up and our meetings were at the Methodist and Congregational Churches, across from the Derby Green. For 30 out of 52 weeks of the year, I would meet my friends at the monument or near one of the four cannons that flank it."

While Jamie would see the monument countless times throughout his life, he did not pay much attention to it until one day, a few years ago. While walking past the monument on his way to a Scouting event, something caught his eye. He noticed a hole where a pin should have been in place to secure a bronze plaque. "Vandals had tried to pry the plaque off the monument. It was then that I noticed the overall deterioration and decided something had to be done."

Jamie was determined that this Memorial to the local men killed in the Civil War would be honored. "I became personally involved in the restoration of the monument," he said. "We hired a specialist to do the work and received \$80,000 from donors to restore the monument to its original beauty. Now, we are taking steps to ensure it stays in good condition moving forward."

"I am honored to have been a part of creating this Designated Fund to provide ongoing annual maintenance to ensure the Monument is appropriately preserved and cared for," Jamie added. "I hope Derby's future youth and young adults will form their own special memories of meeting near the soldier who will continue to stand guard on the Green for generations to come."

The First Taxing District and the Mulvoy-Tarlov-Aquino VFW Post 603 Cannon Preservation Fund



The Valley's roots are far reaching, and often extend beyond geographic and municipal boundaries. Such is the case with the First Taxing District of the City of Norwalk, who has created the First Taxing District and the Mulvoy-Tarlov-Aquino VFW Post 603 Cannon Preservation Fund at VCF.

The French 155 mm Model 1877 DeBange Cannon and pedestal located on the Historic Norwalk Green, was given to the City of Norwalk by France in 1921. In 1950, Post 603 negotiated with the City and eventually obtained ownership of the cannon, displaying it next to the VFW Building on North Avenue and High Street

from 1952-2009. When the building was sold in 2009, VFW Post 603 donated the Cannon to the First Taxing District of Norwalk, which had it restored and prepared for outdoor exhibition. "It is our understanding that this is the last of this model cannons in existence," said VFW Post 603 representative Peter Torrano. "To continue preserving this historic artillery piece that helped maintain freedom in Europe and throughout the world, Post 603 has donated \$20,000 for its perpetual care and maintenance."

As part of the restoration process, a long term plan was created for annual upkeep. Inspired by Jamie Cohen's work in restoring the Civil War Monument on the Derby Green, the District staff began exploring various financial options to ensure that the cannon could be maintained in perpetuity. After contacting VCF, the District found the fit it had been searching for.

"We wanted to make the most of the money we had available to ensure that the Cannon would always be maintained," said Dominick Di Gangi, General Manager for the First Taxing District. "After receiving the generous gift from Post 603, we were able to have the District match it dollar for dollar. Establishing a donor designated fund at VCF allowed us to create a financial distribution mechanism to help carry out the recommendations in the cannon's maintenance and preservation plan, both now and in the future."

First Taxing District Board of Commissioners Chairwoman, Marija Bryant, said, "We are so pleased to be able to work with VCF to ensure that this cannon will be well-kept, and continue to have an honored place on the Historic Norwalk Green. It is a solemn reminder of the tremendous sacrifice our veterans have made to keep our nation the home of the free and the brave."

ORGANIZATION AND FIDUCIARY FUNDS

Nonprofit organizations can set up either a permanent Organization Endowment Fund, which is a component fund of the Foundation, or an Organization Fund, which is for investment only. Both funds provide a stable source of distributable revenue for the nonprofit. On occasion, there are charitable projects that are not attached to a specific nonprofit organization and VCF has been asked to serve as a "fiduciary" to accept the charitable donations and oversee the disbursements in order to fulfill the project.

Massaro Farm Legacy Fund



The Massaro Family ran a dairy farm on 108 acres that originally spanned both Woodbridge and Ansonia for almost a century. Facing similar challenges as many small, family farms in Connecticut, the last surviving member of the family came to an agreement with the Town of Woodbridge in 1994 to preserve the remaining 57 acres under a conservation easement, protecting the acreage from commercial development. Minor agricultural efforts, such as haying, continued to take advantage of the rich soil, but the once active farm remained underutilized until 2008.

It was then that Woodbridge residents decided to breathe new life into the site and share the space with the community in a new and exciting way. These residents formed the nonprofit, Massaro Community Farm, basing it on a community-supported agricultural model with a diverse appeal to a broad audience. The purpose was to establish a vegetable farm that feeds people and nourishes the land. In addition to dozens of types of produce, flowers and honey, Massaro Community Farm has grown jobs and a new sense of community as the farm has gained popularity in Woodbridge and throughout the Greater New Haven and Valley communities.

The creation of the Massaro Farm Legacy Fund marks a new milestone in the farm's history. Caty Poole, Executive Director, explained, "As we approached the 10-year anniversary of the farm, we began to think of ourselves less as a startup and more as a permanent, ongoing resource for the community."

The choice to establish this organization endowed fund with the Valley Community Foundation (VCF) was simple. "A year earlier,

we established a cash reserve fund," Caty said. "Because we know how important it is to be able to weather ups and downs for a farm-based business. But the establishing of a permanent fund – thanks to Paul and Judy DeCoster - that donors can contribute to will ensure that Massaro Community Farm can serve generations to come. It made sense to us to partner with VCF, a local community organization with access to the investment expertise we were looking for."

She added, "Our board, staff, and volunteers are passionate about preserving the farm. We all share the goal of having a place where families can bring their children, and children's children, to learn and make memories. The farm anchors the community in a way that can't be replaced. We hope this Legacy Fund can help further Massaro's mission, making it possible generations to visit us now and for years to come."

Rowland R. Strong and Edith H. Strong Memorial Scholarship Organization Fund



A private foundation, the Rowland R. Strong and Edith H. Strong Memorial Scholarship Fund, Inc. was created by a loving daughter, Miriam, in memory of her late parents. Miriam paid a final tribute to her parents through her estate upon her own passing in 2010 to ensure the educational future for Oxford students remains bright.

A chemist for Anaconda American Brass, and longtime Oxford resident, Miriam Strong's ties to the community were deep. She served for 30 years on the Oxford Inland Wetlands Commission and volunteered her time with a number of local committees and organizations.

Miriam's will detailed the establishment of a private foundation to be overseen by a committee consisting of the Oxford Public Schools superintendent, highest level school principal, and head counselor, along with two Oxford residents.

Superintendent Ana Ortiz said the community relies on its two resident committee members to ensure that the process involves all Oxford students and not just those attending Oxford High School. "Miriam wanted to honor her parents and also recognized that not all families can afford the growing costs of higher education. For someone who really wants to attend a university but does not have the funds, this scholarship is perhaps the only way to make that dream come true."

Miriam's bequest was clear. The primary consideration in selecting recipients should be based on financial need and academic success. Given its immense responsibility as well as the detail involved in managing and administering this renewable scholarship program, the committee decided to involve the Valley Community Foundation (VCF).

"It has been a great opportunity to partner with VCF on the management and due diligence needed to administer a unique scholarship such as this," Ana said. "The staff follows up with students to make sure they remain academically eligible through the four-year renewable award."

"I knew VCF's reputation through their work on other scholarship funds and I knew Sharon well. Her support has been tremendous and, because she attends committee meetings and is very involved with the stewardship of this scholarship, she keeps us moving in the right direction as we develop policies and procedures," Ana added. "We awarded scholarships to two students in 2018 and our intent is to award two per year so eventually, each year eight students will receive support from this scholarship fund. As a result of Miriam Strong's generosity, we hope to demonstrate to our students that their education doesn't have to conclude with high school."

TEAM Legacy Fund



TEAM, Inc. is the Valley's largest nonprofit human services organization with a commitment to economically disadvantaged

and vulnerable at-risk individuals, children, and families in the Valley community and surrounding areas. To ensure its promise for the Valley's most needy will continue to be delivered in the future, TEAM's Board and staff are asking the community for their help. They have established a Legacy Fund at the Valley Community Foundation (VCF) with the goal of building and diversifying their revenue sources for the long term.

David Morgan, TEAM's President/CEO, said, "I often remind myself and our 18-member Board of the important stewardship roles we each have within this organization. While our terms of service are temporary, Valley residents will continue to turn to TEAM, needing help and support well into the future."

TEAM's footprint in the community spans from Early Childhood to Elderly Services. People and families in difficult circumstances can turn to TEAM for immediate assistance and stability, as well as receive help to address their long-term needs on a path to self-sufficiency.

"With the uncertainties of government funding, we need to ensure that those experiencing the deepest need will still find help available at TEAM. We are the safety net for the region and must be ready to respond today and in the years to come," David said.

David recalled a metaphor he heard at a VCF planned giving workshop, which compared establishing a permanent fund at a community foundation to gardening. Rather than a single gift made outright, a fund can be created to support an organization in perpetuity much like turning annual flowers into perennials. "That resonated with me. We can ensure that TEAM will be there for people who, through no fault of their own, find themselves in difficult circumstances. VCF's powerful message made me realize that TEAM and other nonprofits can ensure that our missions transcend our times of service. By incorporating simple planned giving methods, what meaningfully and effectively happens today, has the potential to happen forever."

The VCF staff met with David and TEAM's Board to discuss planned giving and fund options. "The training and technical assistance was phenomenal. They gave so much time and attention to us that it came together rather effortlessly."

"We view VCF as a philanthropic leader in this area," David added. "Like VCF, we, too, are committed to preserving and building upon a diverse menu of resources to impact the community. We know that many people may be more comfortable with giving when they no longer need their assets. Through this Fund, we are able to provide an easy vehicle for those who want to remember TEAM in their estate plans."

Ansonia Public Schools Scholarship Funds



In 2010, Dr. Carol Merlone, superintendent of Ansonia Schools, sought approval from the Ansonia Board of Education to move the scholarship funds, which were kept in passbook savings accounts at the time, to the Valley Community Foundation's (VCF's) comingled investment pool. "It was one thing when local banks were paying significant interest on passbook savings. But with current rates, we needed VCF's management and expertise to keep our funds from being depleted," said Carol.

The Ansonia Schools appreciated that VCF was a local nonprofit that specializes in this type of activity, which led them to invest their scholarships in 2010 in a concerted effort to simplify the scholarship management process. Having administered those funds for the past eight years, VCF earned the trust and confidence of the Schools' leaders who decided to endow the scholarship funds by making them permanent resources at the Foundation. The decision has been beneficial for all involved and allows both organizations to honor the intent of those who wanted to establish permanent scholarships.

Lisa R. Jones, school business administrator, explained, "The Foundation had been previously accepting donations for the funds on our behalf. Last year, Sharon Closius suggested we consider making our scholarship funds part of the VCF endowment rather than for investment purposes only." The change provides an opportunity to expand the longevity of funds that might otherwise have become depleted."

Louis 'Neni' Gaetano, Sr. Derby High School Scholarship Fund



Glenn and his brother, Paul, Gaetano were both astonished and uplifted by the outpouring of their community after the loss of their father in 2011 and decided to do something that would make him proud. By establishing the Louis 'Neni' Gaetano, Sr. Derby High School Scholarship Fund, they are doing more than assisting with the cost of college education. Glenn and Paul feel they are also passing on the encouragement and support that they and their late brother, Louis, Jr., each received from their parents throughout their lives.

Glenn first became involved with VCF in 2006 when he and "Team DeFilippo" helped to establish the Lou and Dolly DeFilippo Scholarship Fund to honor the legacy of their former football coach and his wife. This experience and familiarity led Glenn and his brother to call on VCF's expertise once again.

"We didn't realize the number of people who were making contributions in our father's memory," Glenn said. "We were thinking of giving out a small scholarship each year but, then we

learned we could endow the scholarship fund at VCF. We now can honor our father and mother in a way that lasts forever."

Neni was a permanent fixture in the Valley community, walking his mail route each day for 30 years, and making friends as he distributed letters. He was a lifelong Derby resident who was also a talented Derby High School athlete. It was at Derby High School where he met Margaret "Peggy" Baumer, who would become his wife of 64 years.

"The VCF office on Elizabeth St. is actually on our Dad's old route. Since Derby is so small, it has always been easy to get to know people. We were fortunate to grow up in Derby and my parents loved the city," Glenn added.

Each year, scholarship recipients write the Gaetano Family letters of gratitude. "It's heartwarming to read these personal notes of thanks," Glenn said. "I like to write back and ask how things are going. On behalf of our father, I share our well wishes for success in school and in everything that they do. We are proud that, as a result of endowing this fund, it will be a permanent fixture at Derby High School, just as our dad was in this community throughout his entire life."

Ann C. Petro Scholarship Fund



There is a saying that a life well-lived is a life filled with love. Ann Petro's life was indeed well lived. Her family and friends, and her Valley home and gardens filled her with tremendous joy and pride. She brought passion to everything she did - as an educator, reading teacher, and eventual Principal of Sunnyside School in Shelton.

Ann's dedication to her students, parents, staff and colleagues was immediately evident to all who entered the building, and remained long after the last bus left at the end of the school year. That's why it's no surprise that her family created the Ann C. Petro Scholarship Fund to honor their mother's memory after her passing in 2018, and to recognize and reward the students of Sunnyside School.

"In 2014 when her grandson, Christopher Pawlowski received awards at the Shelton High School senior awards ceremony, mom noted that there were awards for students of other elementary schools, but none for those who had attended Sunnyside" said daughter Pam Petro. "She was troubled by this. Due to everyone's generosity and support when she passed away, our family created this fund to ensure that former Sunnyside students would be recognized both now and in perpetuity."

"Our mom's entire life was spent in the Valley and she was a proud supporter of its traditions," said daughter Melanie Petro. "She, like all of her family, lived and worked here. We never missed the Shelton Derby Memorial Day parade, the Boys & Girls Club pancake breakfast, or the Shelton/Derby football game. It was all a part of our growing up in the Valley – and all the wonderful things she passed down to us."

The Petro Family chose to work with VCF because it "keeps the Valley spirit alive by inspiring others to care about our special community," said Melanie. "When she retired, mom could have moved to other, warmer places like Florida. She chose to stay in the Valley, because to her it wasn't about the place, it was the people." Pam agreed. "The Valley is unique and special. People here truly care about their neighbors, just like our mom always did. The diverse group of funds at VCF reflects that care and concern and we are so glad to add our mom's Scholarship Fund to that list."

Seymour Historical Society Scholarship Fund



One of the most valuable lessons in preserving the past is investing in the future. That is why the Seymour Historical Society wanted to share with young people its special appreciation for local history by establishing the Seymour Historical Society Scholarship Fund with the Valley Community Foundation (VCF).

The Gates Society is a close circle of friends who share a special love and appreciation for this region, and who have named the Valley Community Foundation (VCF) in their estate plans.

The Society is named in honor of Ross and Frank Gates, the brothers of a prominent Derby family. In 1938, the brothers created trusts in the family name at The Community Foundation for Greater New Haven (TCF) to support broad charitable purposes with consideration that the income benefit the residents of Derby and vicinity. Today, this fund continues to support the Valley with more than \$1.1 million annually.



Stewardship of Charitable Assets

The Valley Community Foundation (VCF) and The Community Foundation for Greater New Haven (TCF) have been affiliated for the past 15 years, and the assets entrusted to VCF since 2004 have been invested and managed by TCF. Access to TCF's commingled investment management program affords VCF funds the benefits of a diverse, long-term and global endowment model by providing exposure to over 40 world-class sub-advisors across 10 asset classes.

VCF posted a return of (4.9%), net of the expense of managing the Commingled Fund against the market benchmark of (5.5%) for the year ended December 31, 2018. Even during these times of financial volatility, the annualized net return of the Commingled Fund for the trailing 3, 5, 7, and 10 years consistently outperformed benchmarks, which are all greater than VCF's effective spending rate. It is due to the design of the spending policy and calculations over a trailing five-year average that distributions can be managed in a predictable way.

Mission Related Investments

Thanks to VCF's relationship with TCF, a new facet of community engagement and impact is now on the horizon through Mission Related Investments (MRIs), which represent an exciting new opportunity for Valley businesses and nonprofits.

Philanthropic dollars can often bridge the gap between the community's need for capital for important and emerging projects and what the private market will provide. MRIs pave the way for other investors by evaluating both the community impact and the potential financial returns, and by conducting due diligence on opportunities that the private market might not otherwise consider due to size, scale or perceived risk. MRI investing is a logical extension of work TCF has been doing for many years with donors, nonprofits, and local entrepreneurs and enterprises.

MRIs seek to support organizations and projects in ways that align with and further our mission, including those that provide the opportunity to collaborate with donors and to bring individuals, businesses, and organizations together to improve the community.
