A Year in Review

Dear Friends,

As you know, the Valley community is blessed to have so many engaged and civic-minded members who have cared deeply about our region for generations. A rich heritage of manufacturing and collaboration are the hallmarks of our five towns. Much like this year's theme, our strength is in working together to achieve more.

At the Valley Community Foundation (VCF), we are partnering with our nonprofit community by providing resources, strengthening and empowering our local organizations to make a more measurable impact in the Valley. Thanks in part to the collective knowledge from nearly 50 community members and representatives from local nonprofits, school administrators and local officials, we released The Valley Now: A 2015 Snapshot. This Snapshot serves as a timely baseline report on the socioeconomic trends apparent in Ansonia, Derby, Oxford, Seymour and Shelton, including Beacon Falls and Naugatuck.

In the next phase of our continued effort to build an informed community, we are convening work groups consisting of dozens of representatives from more than 30 organizations in support of the 2016 Community Index. This Index, which will include wellbeing phone survey data, represents the start of a multi-year commitment to learn about the changing needs and opportunities in the Valley, culminating with the release of a comprehensive, single-source report in the fall of 2016.

We also proudly released the Your Valley – Your Legacy brochure, the first step in our Valley Gives Back initiative. We hope this publication inspires our readers to take action by remembering their favorite Valley charities or the causes that matter with a gift in their estate plan. This piece provides simple examples of legacy giving and shows how planned gifts can fit into everyone's financial plan. Imagine the impact on the Valley if we each gave as little as 5% of our estate!

Lastly, after three years as the VCF Board Chair, John Zaprzalka is turning the gavel over to Alan Tyma. Alan brings a wealth of experience to the Foundation. Now in his second seven-year term, Alan was a founding VCF Board Member and has served as both a Board Member and Chair for our partner in philanthropy, The Community Foundation *for* Greater New Haven.

As you read this annual report, we hope you will see that, together, we are all making great strides to create a stronger, more vibrant community today and for generations to come!



DISCRETIONARY GRANTS BY PROGRAM AREA PAID IN 2015





By understanding the needs and opportunities of our region through data collection, we are setting the stage to make a collective impact on our community. The Valley Now: A 2015 Snapshot was published in April of 2015 and spotlights trends using existing data as a baseline report. Since the report was published, cross-sector work groups comprised of more than 30 organizations have regularly assembled to discuss the data critical to our community.

This report represents the start of a multi-year process, which will culminate with a comprehensive study on the demographic, economic, education, health and housing trends within the region. It is the goal of all organizations involved to produce a community index in which the data will be used to convene community conversations, align current efforts and investments, and collaborate on strategic endeavors to build, sustain and enhance the quality of life in the Valley.

This index will also be completed in fulfillment of Griffin Hospital's Community Health Needs Assessment and will be revised with new data every three years to maintain a pulse on the region.

It is the fervent hope of all involved to create an even stronger and more vibrant Valley for generations to come.





The Valley Community Foundation (VCF) unveiled Your Valley – Your Legacy, a Valley-wide initiative that aims to inspire people to consider making a planned gift. We encourage individuals to discuss their charitable ambitions with their professional advisors, such as accountants, attorneys and financial planners.

Many individuals are more comfortable giving a larger gift after their life due to expenses related to retirement planning and end of life costs, which can sometimes be unforeseen. THE GREAT GIVE® 2015

Coming Together for Something Great









The Great Give® 2015, a 36-hour online giving event that benefits nonprofits serving the Greater New Haven region, increased by 51% over 2014. Overall, a 43% increase in giving from Valley residents and employees, combined with matching grants and prizes, totaled nearly \$230,000. The results prove the Valley is a philanthropic region and its people understand the importance of giving locally in a global world where so many charitable options exist.

Valley nonprofits raising the most dollars were: Center Stage Theatre, which also won a second place Grand Prize from The Community Foundation for Greater New Haven for attracting the most donors, Boys & Girls Club of Lower Naugatuck Valley, BHcare, TEAM, Inc. and Griffin Hospital. In addition to Center Stage Theatre and TEAM, organizations receiving the most gifts were Seymour Pink, the Shelton High School Robotics Team and the Valley Independent Sentinel, who conducted the first ever 36-hour live webcast during the event.

The Great Give® 2015 generated \$1,291,096 including matching funds and prizes, for nonprofits working in the 20-town area served by The Community Foundation for Greater New Haven, which includes VCF's five-town region. Champagne Family Fund

The Valley is a special place. It's not just a community where people live. It has a feel to it. Everyone seems to genuinely care about each other and is involved with one another. According to Jennifer Champagne, it's something very unique.

"From an early age, I watched my parents, Nick and Ernie Luise, deeply involve our family in the Valley community," Jennifer said. Through her parents' experience with the Derby/Shelton Rotary Club and a range of local, regional and international nonprofit organizations, community involvement has become a way of life for Jennifer. "Now, my husband, Derrick, and I want to share the same experiences and values with our daughter, Aimee."

"Everyone's needs are both important and different," Jennifer said. For example, Aimee started giving gift

cards to the homeless on the streets of New York City long before she could even drive. Her social awareness and her family's desire to make a difference led to conversations about other ways the Champagne family could create an impact here in the Valley.

"Setting up a donor advised fund at VCF allows us to address changing local needs while including Aimee in our family's rich tradition of community involvement," Jennifer said. "Establishing a fund was a simple process and a great way to inspire future generations to care just as much as we do. It allows us to create a legacy to share with our family that will outlast all of us, address the needs of others and always keep the Valley top of mind."



Valley Breast Health Care Fund

There is profound strength in numbers, especially when it relates to advocacy. Local agencies and community representatives, under the auspices of Griffin Hospital, came together more than sixteen years ago to discuss pressing topics concerning women's health in the Valley and, among the issues, was breast cancer awareness.

Statistics at the time showed a climbing rate of breast cancer deaths in the region. The Valley Women's Health Initiative, comprised of health and community members, was formed with a clear objective – intensify local breast cancer awareness with the hope of improving access to breast cancer screening and diagnostic imaging. The research was clear, when detected early and treated promptly, the survivability of breast cancer is greatly increased.

The purpose of this ongoing effort is to reach out to those who cannot afford the cost of breast cancer screening and diagnostic imaging and enable them to receive it. Working in collaboration with Griffin Hospital and other breast health facilities, the advisory committee wants to ensure no patient is turned away when the avenues of federal, state and local grant monies have been exhausted.

What started as an initiative to educate women as well as local physicians, grew to hosting fundraisers to engage community members, providing free mammograms, and advocating for women's health. Their collective voice led to many positive changes in educating and informing the Valley community, supporting legislation and grant funding – all in an effort to increase the early detection and treatment of breast cancer.

"More recently, we began seeking a local investment partner who could understand and support our objectives, said Kate Cosgrove, Committee Co-Chair. "After careful consideration, VCF became our selection to assist us in growing the Valley Breast Health Care Fund."

Diagnostic imaging, medical treatments and patient advocacy have advanced over the years, but continue to fluctuate. There is hope that a day will come when breast cancer will have an ultimate cure. "Until that time comes, the Valley Breast Health Care Fund is able to address many needs in the vast area of breast wellness," Kate said. "The legacy of what we are trying to achieve will continue far beyond any of us."



Joe and Judy Zaprzalka Family Fund

They say family is like the branches on a tree – each growing and expanding in different directions but its roots remain the same. For the Zaprzalka family, their roots are firmly grounded in the Valley.

Joe and Judy Zaprzalka were born and raised in Derby, attended Derby High School and moved to Shelton in the 50s to start their family. Judy was a homemaker while her children were young and later worked outside their home. Joe worked in and later owned a printing business and was a volunteer firefighter at Echo Hose during the 60's. He was also was a lifelong member of the Highland Golf Club where he served on its Board and socialized over the game he loved to play.

Both Joe and Judy were dedicated to their children and families. They loved the Valley and often helped wherever or however they could, and would frequently remind their children of the importance of supporting their community.

As their children Michael, Thomas, John and Susan grew, so did the family's involvement in the Valley community. "My brothers and I have been and will continue to be involved with Valley charities," Susan said. "We all learned how to swim at The Recreation Camp and were members of the Boys & Girls Club. Now, as adults, we serve on the boards of many of the organizations that made an impact on our lives growing up."

The Zaprzalka family had been considering setting up a fund for a number of years, and was particularly familiar with VCF through its support of organizations in which they volunteer. "We created the Joe and Judy Zaprzalka Family Fund to support Valley nonprofits that have been so special to us," said Tom. "This endowed donor advised fund is a way to honor our parents and the community-minded, philanthropic values they instilled in us. Since all of our children will eventually have a say in which charities will benefit from the Fund, we hope they, too, will learn that giving back is important, feels great and really does make a difference."

ORGANIZATION FUNDS

Nonprofit organizations can set up either a permanent Organization Endowment Fund, which is a component fund of the Foundation, or an Organization Fund which is for investment only. Both funds provide a stable source of income for the nonprofit.





Plumb Memorial Library Reserve Fund

Libraries in the Valley and across the nation have transformed into community resources and access points to new technology for people of all ages. The Plumb Memorial Library prides itself on providing a variety of services to Shelton and surrounding communities. As the programming and services for local residents adapt, so do the libraries' strategies, including its approaches to managing its resources.

The Plumb Memorial Library's Board carefully reviewed its investment options and decided to establish a fund at VCF, creating the Plumb Memorial Library Reserve Fund.

"The Library witnessed the success of VCF's long-term investment strategies and wanted to avail itself of the Foundation's professional financial management," said Aleta Miner, Treasurer of the Plumb Memorial Library's

Board of Directors. "Having access to a commingled investment management program like this allows a little fish, like our Library, to swim in quite a large pond."

"The Library has been aware of VCF's growth and support for so many of the Valley's nonprofit organizations," said Barbara Glover, Plumb's former Board Chair, "This was a great opportunity to partner with our local philanthropic community foundation."

VCF's funds are invested with The Community Foundation for Greater New Haven (TCF), which has more than \$500 million in charitable assets and operates a diversified long term approach to charitable funds' management. The assets are managed with a "total return approach" to generate predictable current distributable revenue to respond to charitable needs, while providing for long term growth by protecting the dollars against the effects of inflation.



Shelton Historical Society Endowment Fund

The Shelton Historical Society (SHS) preserves elements of the community's history in order to create lasting and meaningful connections between Shelton's past, present and future generations. By maintaining a museum and providing a voice in the community regarding matters of historical significance, the Society strives to build an awareness of and appreciation for the rich 300 years of history through educational programs for both young and old.

To help ensure their future of preserving the past, the Society's staff and Board began researching options that could provide SHS with a long term sustainability plan. "We explored several different alternatives, and found that creating an endowment fund with VCF could assist us in reaching our long term goals," said SHS Board President Marty Coughlin. "We worked with both the Community Foundation for Greater New Haven and VCF on a number of grants for renovations to our buildings and educational offerings. Then we learned VCF could also provide endowment management. This was a logical next step in our partnership."

Whether it's educating grade school classes about such things as how food didn't always come from a supermarket, or how butter used to be churned for hours before it could be used, SHS wants to offer community events and programming to share the way of life from the early 1700's to the present for years to come. SHS also shows how people interacted with each other years ago and the ways in which Shelton evolved from a rural agricultural area to the thriving city it has become.

"At the Historical Society, we often say a community that forgets its past loses its soul," said Marty. "We preserve the items and experiences of the past so their legacies can endure for future generations. In a way, both VCF and the Historical Society are in the business of preserving the memories of the past so the legacy of those who called the Valley home can live on. We are pleased to be able to create this Fund to help SHS do its part to sustain and share Shelton's rich heritage."

Rachel and William Brogadir Scholarship Fund

Sometimes humble beginnings can lead to extraordinary action. Rachel and William Brogadir moved from Brooklyn, NY to Ansonia nearly 70 years ago. It was there that they opened a grocery store and raised a family. Rachel made their house a home, loved art and

always seemed to have classical music playing softly in the background.

"Education was our parents' number one priority for us," said Dick Brogadir, one of their three sons. "From the time we attended Larkin School, Ansonia High School and went to college, they supported our interests in pursuing higher education."

The family started a scholarship fund at Ansonia High School after Rachel passed away in 1997 to benefit graduating students pursuing her passions of art and music. Upon William's passing in 2014, he left a bequest in his will that included a portion of his estate to support the scholarship.

"I spoke with my jogging partner, Greg Stamos, VCF's former Board Chair, about creating an endowed scholarship fund so it could be awarded in perpetuity," Dick said. "The scholarship money was previously earning very little interest, so this was a great opportunity to support the graduating seniors of Ansonia High School forever."

After speaking with Sharon Closius, VCF President and CEO, Dick and both of his brothers contributed to establish an endowed scholarship fund in their parents' name. "Our parents supported us in pursuing education to achieve stable careers. This is our way to honor what they did for us and give back to Ansonia High School by supporting graduating students for years to come," Dick said. "It was very simple to set up this Fund. We hope the scholarship recipients will be successful in their respective fields of art or music so they can have a similar feeling of accomplishment through education as we did."

Stanley and Irene Chlebowski Memorial Scholarship Fund

Irene and Stan "Smiles" Chlebowski, were life-long Valley residents who taught their children the importance of supporting the Valley community from a very early age. Stan was born in Derby and attended Derby Public Schools, was a WWII Veteran, and a longtime member of the Highland Golf Club. Irene was born in Shelton and attended Shelton Public Schools. She was a homemaker, as well as an enthusiastic sewer and knitter.

Their children, Bob Chlebowski and his sister Susan, both formerly of Shelton and now living in San Francisco, CA and Rochester, NY respectively, wanted to honor their parents' love for the Valley. Bob began searching for a way that would best meet their needs and found the Valley Community Foundation during an online search.

"We contacted VCF and found that they provided the endowment opportunities that we were looking for," said Bob. "We were able to do all of this over the phone and via e-mails long distance. It was straightforward, easy and took no time at all."

Bob and Susan established the Stanley and Irene Chlebowski Memorial Scholarship Fund in memory of their parents. Each year, this Fund will provide one graduating Shelton High School senior who is pursuing nursing or an allied health field with a scholarship that is renewable up to four years.

"Shelton provided Susan and I with the benefits of a growing up in a small town where everyone knew each

other," said Bob. Susan agreed. "Our dad earned the name 'Smiles' while working at the former Sponge Rubber Products company in Shelton," said Susan. "The nickname stuck because he was always smiling, never had a bad thing to say and would give anyone the shirt off his back."

"Our parents always stressed the importance of education as a way to grow professionally and as a person," said Susan. "They made great sacrifices for our education and we could not think of a better way to honor them than by creating this scholarship at VCF."



Brandon Giordano Football Scholarship Fund

Oxford High School mourned the untimely death of a student in March of 2012 when 15-year old sophomore, Brandon Giordano, tragically passed away in an automobile accident. Thanks to an outpouring of community support, Angela Borrelli, Brandon's mother and a life-long Oxford resident, created a scholarship to honor Brandon's memory and benefit a graduating member of the football team who shared his enthusiasm for life.

Football had recently become a big part of life for Brandon. For him, it was about brotherhood, respect and discipline – many of the qualities that have a lasting impact both on and off the field. "It wasn't until his

passing that I learned how his true impact within the high school community and among his peers went far beyond anything I could have imagined," Angela said. "The amount of people he touched with his humor, smile and generous bear hugs is incredible, and is something that nobody will ever forget."

The conversation about what more could be done with the scholarship fund started when a friend of Angela's suggested she endow the scholarship at VCF so the fund, like Brandon's legacy, could benefit Oxford students in perpetuity. Angela hopes this annual scholarship will help a graduating senior member of the football team, who exemplifies Brandon's attributes and team-spirit, by defraying some of the rising costs of higher education.

According to Angela, establishing an endowed scholarship fund was very easy. "I was able to better understand community foundations after meeting with Sharon Closius, VCF President and CEO, to discuss similar funds that were endowed at VCF." Angela added, "I especially liked how VCF is a local organization that specifically focuses on the Valley. This whole experience has been so personal, not transactional."

"Brandon had such a big heart, positive attitude and infectious laugh that never failed to bring a smile to others," said Angela. "Having this scholarship at VCF helps to ensure that Brandon's life will be honored for all the wonderful things he did and as the special young man we were so fortunate to know."



Randall R. Holden Memorial Scholarship Fund

It is never easy to lose a loved one, especially a child and sibling. The Holden family knows this all too well after the sudden passing of their son, Randall Rapp Holden in 2001. Their community, too, felt deeply the loss of his bright and creative spirit. As a result of the tremendous outpouring of support they received at the time, the Holden family initially created a scholarship fund at Amity High School in Woodbridge, where Randy had been a member of the graduating class of 1999.

To expand the Fund's ability to accept different gift vehicles, the Holdens worked with Amity High School, who graciously agreed to transfer this scholarship to the Valley Community Foundation. "Schools in general are not positioned to accept different types of gifts," said Randy's parents, Allen and Jo-Anna. "This move has allowed us to make use of several different gift vehicles to contribute to the Fund, including a gift from our IRA, as well as the use of appreciated stock. In addition, our daughter, Katrina Holden-Buckley, is providing support through matching contributions from her employer."

The Holdens have also made provisions to add to their Scholarship Fund through their estate plan, becoming members of VCF's, planned giving community, the Gates Society. The scholarship is given to a college-bound

The contributions made in Mr. Pagliaro's memory have enabled the scholarship to become a permanently endowed fund at VCF. The scholarship is awarded to a high ranking student accepted to a four-year college, whose community and school service has improved the quality of life in those respective areas.

The scholarship from the Shelton High School Education Fund is presented to a graduating senior(s) that exemplify the traits of the Gael guidelines: respect, responsibility and safety.

Dr. Beth A. Smith, Headmaster of Shelton High School, said, "Shelton High School is a learning community with high academic expectations. We are proud these two awards can become endowed funds at VCF and together we look forward to supporting the well-deserving graduates of Shelton High School for years to come."



Responsive Grant Program

VCF's annual Responsive Grants process is open to all requests for organizational support and projects that serve Ansonia, Derby, Oxford, Seymour and/ or Shelton. These grants are generally awarded to address a nonprofit's operating, programmatic, or capacity building needs.

Stewardship of Charitable Assets

Despite a turbulent and volatile year in the global markets, stewardship of the Valley's charitable assets again generated positive net investment returns in excess of the market benchmarks.

The Valley Community Foundation (VCF) and The Community Foundation for Greater New Haven (TCF) have been connected through a solid philanthropic partnership throughout the past 12 years. The assets entrusted to VCF have been managed in cooperation with TCF since VCF's inception in 2004. This access to TCF's commingled investment management program through TCF's Corporation, which has been a Connecticut registered investment adviser since 2014, affords VCF the benefits of a diverse, long-term endowment model allocated across domestic and international segments of the market through the retention of 39 world-class sub-advisors across nine asset classes.

VCF is pleased to report that, despite a down year where many market indices and benchmarks produced negative returns, the organization reported a 2.6% return, net of the cost of the sub-advisory expenses, against the market benchmark of (0.8) for the year ended December 31, 2015. We are proud that since VCF's inception, the endowment has had a consistent annualized return of at least more than 2% above the market benchmark, after the costs of producing that return.



"VCF is proud to partner with TCF, who manages our assets and endowments. Our successful investment program exists because of a strategic asset allocation framework designed by TCF. VCF funds benefit from participating in TCF's solid
